This policy was last updated on 9th November 2024 and will be effective from the date you sign up to a Dancers Network membership

Welcome to **Dancers Network**! We are excited to have you join our community of dancers and enthusiasts. By subscribing to any of our membership plans, you agree to the terms and conditions outlined in this Membership Policy. Please read it carefully.

This policy applies to all members of **Dancers Network**, regardless of their membership level. Whether you are subscribing to THE NETWORK, THE MOVEMENT LITE, THE MOVEMENT, THE MOVEMENT PLUS or any other membership options, your subscription is subject to the following terms.

1. Membership Levels

Dancers Network offers multiple membership levels designed to cater to different needs and interests. Each level has specific benefits and requirements.

a. THE NETWORK

- **Features:**
 - Access to our 'Dancers Network Terms & Conditions' as well as our Rates resources (e.g., introductory articles, coffee meets, public forum discussions).
 - Limited access to some members-only content.
- **Restrictions:**
 - No access to premium content or free Advocacy support
 - Limited customer support.
 - No voting or participation in members-only polls and events.

b. THE MOVEMENT/THE MOVEMENT LITE (*Paid*)

- **Features:**
 - Full access to all free content plus premium resources (e.g., exclusive content, downloadable materials).
 - Advocacy support
 - Access to members-only forums and private social groups.
 - Priority email support.
 - Access to some exclusive events and workshops.
- **Restrictions:**
 - No access to the highest-tier content, such as our contract lawyer

c. THE MOVEMENT PLUS (*Paid*)

- **Features:**
 - All benefits of Basic Membership, plus:
 - Full access to all free content plus premium resources (e.g., exclusive content, downloadable materials).
 - Advocacy support
 - Access to members-only forums and private social groups.
 - Priority email support.
 - Access to some exclusive events and workshops.
 - VIP access to events and community features.
 - Full access to the entire archive of video content and downloadable resources.
 - Early access to tickets, event bookings, and special offers.
 - Contract lawyer access
 - **Restrictions:**
 - None. Premium members enjoy full access to all features and content.

2. Subscription and Billing

- **Subscription Fees:** Membership fees are outlined on the subscription page of our Wix website. Fees for each membership level are subject to change. Any changes will be communicated in advance.
 - **Payment:** All membership payments are processed securely through third-party payment providers such as Wix Payments, PayPal, or Stripe. By subscribing to any of our paid membership plans, you agree to the payment terms set by the payment provider.
 - **Billing Cycle:** Membership fees are charged on a monthly basis with an annual commitment, depending on the plan you choose. You will be billed automatically at the start of each annual cycle, unless you cancel your subscription prior to the renewal date.
 - **Refunds:** Membership payments are non-refundable, except in cases of service failure or as required by law. You may cancel your membership at any time, but you will not receive a refund for any charges already incurred during the current billing period and will keep your membership until the end of any committed period
